### What This Privacy Policy Covers

\* This Privacy Policy covers SC's treatment of personally identifiable information that SC collects when you are on the CorazonTequila.com site. This policy also covers SC's treatment of any personally identifiable information that SC's business partners share with SC.

### Information Collection and Use

### Information Sharing and Disclosure

\* SC will not sell or rent your personally identifiable information to anyone.

\* SC may send personally identifiable information about you to other companies or people when:

- o We need to share your information to provide the product or service you have requested;
- o We need to send the information to companies who work on behalf of SC to provide a product or service to you. (Unless we tell you differently, these companies do not have any right to use the personally identifiable information we provide to them beyond what is necessary to assist us.);
- o We respond to subpoenas, court orders or legal process; or
- o We find that your actions on our web sites violate Jagar.com Terms of Service or any of our usage guidelines for specific products or services.
